#### **Administration Changes**

Mr. Wilson has accepted a position as the director of employee services for the district. He expressed mixed emotions as he has loved serving as an administrator for the last 15 years, 7 of those at MHS. Council members expressed gratitude for his years of service to MHS.

Mr. Thomas, current Vice Principal, has accepted the position as MHS Principal. Mr. Thomas was first hired as the Instructional Coach at MHS before moving to Vice Principal. Mr Thomas expressed that a top priority for him is what happens in the classroom and that he will strive to be visible to teachers and students.

## **Trust Lands and TSSA Budgets for 2023-2024**

Due to issues with the Trust Lands website Mr. Wilson was unable to update the plans for the 2023-2024 school year to present to the Community Council. Mr. Wilson did present the plans without the formal Trust Lands update.

The budgets for Trust Lands and TSSA for 2023-2024 are: Trust Lands: \$229,000 and TSSA: \$160,000. Many items will be carried over from this years plans including: a part time Orchestra teacher, an IT Specialist, a full time English Teacher, a part time Math Teacher, Software Purchases and Professional Development. New proposals for this year include funding a certified teacher for the MULC (Morgan Unified Learning Center) and a College and Career Advisor in the Counseling Center.

### ***Additional Discussion***

Mindy expressed concerned about the trash problem in the parking lot and asked if there was anything the Community Council could do to help. There was discussion about adopting a policy and ways to enforce the policy. The Student School Board also has concerns and has purchased 3 outdoor garbage cans that will be set in place after snow melts.
