### **Consent Items:**

### **Agenda Items:**

#### ***MHS Student School Board Report on Dress Code***

- This year Morgan High School has created a Student School Board. The board is made up 14 students (freshman to senior) who were nominated by teachers and selected by the administration. The board meets regularly and discusses topics relevant to students at Morgan High.
- Recently the Student School Board has been discussing the Dress Code section of the handbook.
- Alta and Jayden presented the Student School Board recommendations to the Community Council.

### ***Committee Reports***

Policy (Mindy Savage): The committee is continuing to review all the state policies for reviewing curriculum or books used in teaching and in the library. They will make a recommendation to the School Board when they have finished reviewing.

### ***Safety Plan***

- Mr. Morrell presented aspects of the schools safety plan.
- The main safety plan is district wide and can be found on the district website.
- The administration is excited about a new communication tool the High School is piloting for the district. Alerts can be sent by email and text to all teachers, staff, etc. The district safety officer also receives the alerts.
- Last week the school had a scheduled evacuation drill and the alert system worked well. Shana Croft mentioned it worked great as she was out of town when she received the alert and was able to notify her sub (the substitute was also notified by the office).
- Mr. Morrell reviewed the schools evacuation protocols.
- A key to safety is teacher and staff training. Mr. Morrell is checking about having a district wide training for substitutes. Shana Croft suggested the administration remind teachers to make sure they leave the safety plans and protocols with their subs.
- Mr. Wilson has been working with a security company and local law enforcement to identify weak spots in the security system and camera placement.
- The security company is also providing a bid for electronic door locking systems for the district.
