

## **MHS Community Council Meeting Minutes | February 28, 2023**

Meeting called to order at 6:42 a.m. by Diana Windley. (The meeting was delayed due to road conditions from a snow storm).

### **Consent Items:**

Minutes for the January 24, 2023 monthly Community Council meeting. Motion to approve by Mindy Savage with a 2nd from Beth Belinski. Motion passed unanimously.

### **Agenda Items:**

#### ***Committee Reports***

Policy (Mindy Savage): The committee discussed the proposed changes to the Valedictorian policy. Changes to the Dress Code policy were also discussed briefly.

Safety (Jeff Kelsey): The committee discussed the reunification plans for each school. Mr. Wilson shared the I Love You Guys resource with all parents in an email. (Mr. Wilson shared the plans MHS is working on for reunification. There is a committee with administration, the school nurse and the school resource officer who are reviewing the plans and making a recommendation.)

#### ***Valedictorian Policy***

Mr. Wilson and Mindy shared questions and concerns about the proposed policy from the policy committee and the school board. Clarifying language was added and concerns and questions were answered by those who served on the committee that

wrote the proposed policy. Mr. Wilson and Mindy will report back to the policy committee in March.

### ***Dress Code Policy***

The policy committee will continue to review the Dress Code policy. Mr. Wilson will report back if they have any questions or concerns.

### **Trust Lands and TSSA Budgets for 2023-2024**

Diana emailed a document from the state outlining the appropriate use of Trust Land Funds for the council to review before the meeting.

Mr. Wilson presented his recommendations for the Trust Land and TSSA funds for 2023-2024. He recommend goals from 2022-2023 continue with the exception of the instructional coach. The district will pay the full salary for the instructional coach for next year. MHS will also receive an increase in Trust Lands Funds for 2023-2024. New goals include funding for Morgan Unified Learning Center (this is especially needed as the district will discontinue it's online school next year) and funding for an employee in the Counseling Office that focuses College and Career Readiness.

Motion to approve Mr. Wilson proceeding with writing the plan to include the recommendations presented by Shana Croft with a 2nd from Jeff Kelsey.
